The largest operators have set up their own trusts, which are either administered directly by their own staff, or contracted to national organisations, such as Groundwork, or the Wildlife Trusts.

Where a church building is an accessible space available to the whole community, the enhancement of its use, or the conservation of its fabric may well fall within the grant criteria of the schemes.
